

## **Service Contract Reports (SCRs) in SAM.gov Federal Users**

### **Who Can Submit Service Contract Reports?**

Entities registered in SAM.gov that have one or more contracts awarded to them that meet the SCR reporting thresholds can submit SCRs.

Refer to **"FY2022 Service Contract Reporting Criteria"** on page 6 of this guide to learn more about which contracts are eligible for reporting.

### **How Do I View a Submitted SCR for an Individual Entity?**

Federal government users must be signed into their SAM.gov account and must have the "View Entity FOUO Compliance Reports" permission added to [one of their roles](#) to search for and view SCR information.

1. Sign in to SAM.gov.
2. Select "Search" from the header menu.
3. Select the "Select Domain" tab from the menu on the left side of the page.
4. Select "Entity Information," then "Entity Registrations."
5. Use the filters that display on the left to search for an entity.
6. Open the entity registration record by selecting the entity name in the search results.

- On the entity details page, select the “Entity Reporting” tab from the navigation menu on the left.

- Total FTEs is the sum of the calculated prime contractor FTEs and any calculated subcontractor FTEs.

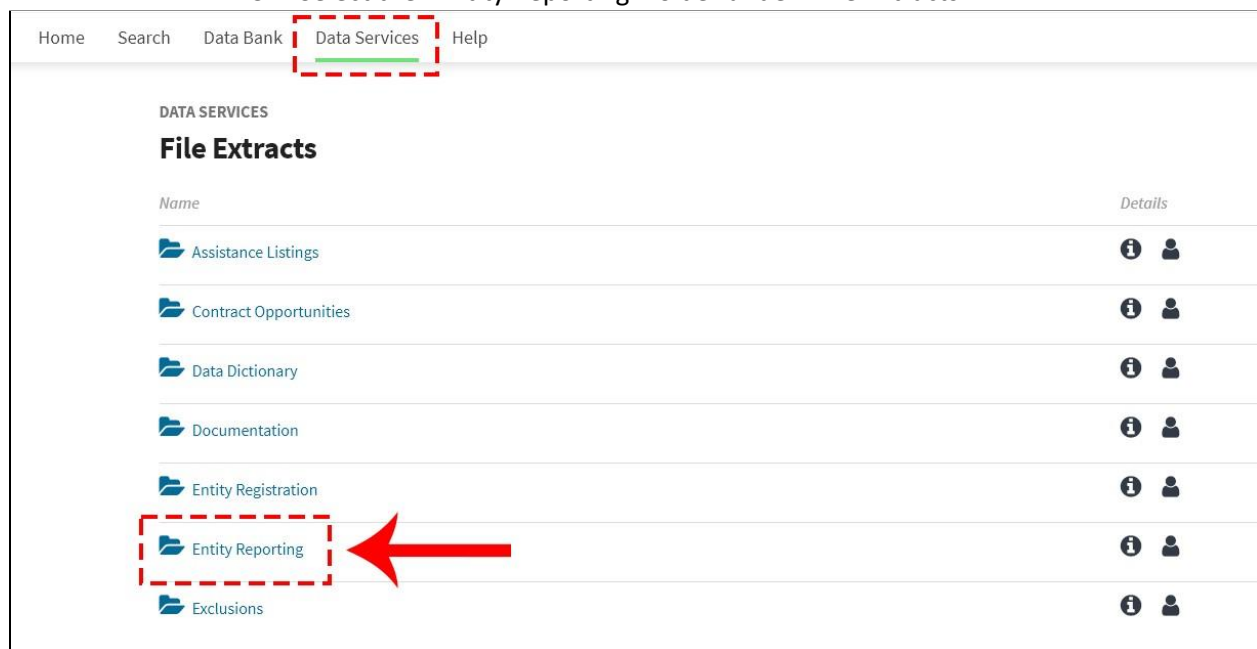

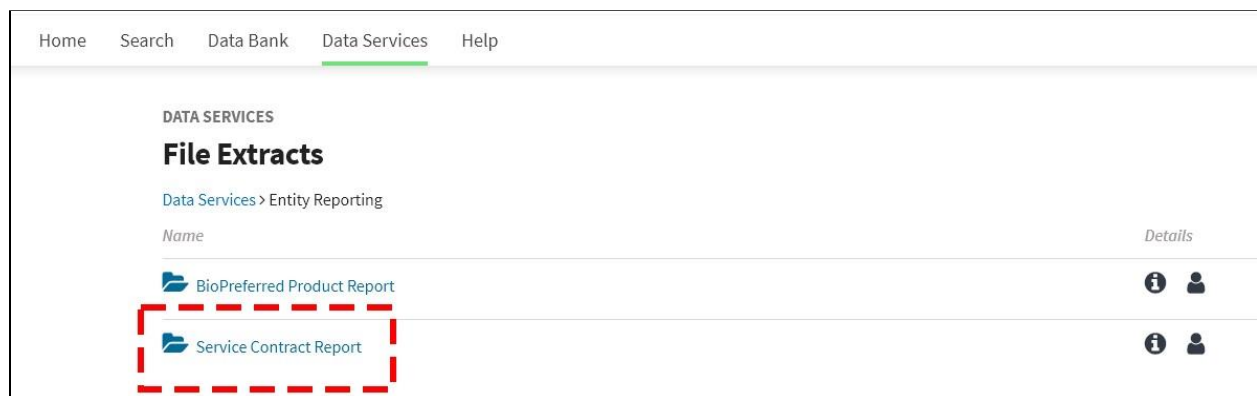
## How to View Weekly Interim Reports

As with submitted SCRs, you must have the “View Entity FOUO Compliance Reports” permission to be able to view weekly interim reports.

1. Sign in to SAM.gov.
2. Select “Data Services” from the header menu.
3. Select the “Entity Reporting” folder under “File Extracts.”



4. Then select the “Service Contract Report” folder and download the available ZIP file.



## FY2022 Service Contract Reporting Criteria

Contract Action Type	
1	Include BPA calls, purchase orders, awards that are delivery orders or task orders under an Indefinite Delivery Vehicle (IDV), and Blanket Purchase Agreement (BPA) calls. (12B codes A, B, C, and D, respectively in FPDS)
2	Exclude Indefinite Delivery Vehicles (IDV) (12A in FPDS)
Contract Completion Status	
3A	<b>Civilian Agencies</b> Include actions with a Base Effective Date (2B in FPDS) between 10/01/13 and 09/30/22 inclusive for civilian agencies;
3B	<b>DoD</b> Include actions with a Base Effective Date (2B in FPDS) between 10/01/08 and 09/30/22 inclusive for DoD. <i>Note: DoD awarded contracts are delayed from appearing in FPDS for 90-days. Align business rules to ensure the entire eligible pool is included.</i>

14	For DoD, include FY09 to FY22 awards where the total net amount of obligations in FY22 is either greater than \$3M or less than -\$3M (Anything between -\$3M to \$3M will be excluded)
